Articles of association

Pursuant to Section 8 (4) of Act CCIV of 2011 on National Higher Education (hereinafter: Nftv.) and Act XXII of 2021 on the Rudolf Kalman Foundation for Obuda University, the Rudolf Kalman Foundation for Obuda University and the property benefit for Obuda University, in accordance with the provisions applicable to non-state higher education institutions, I hereby issue the founding charter of Obuda University as follows:

1. Name, headquarters, locations of the University

- 2.2. Maintainers's rights and obligations:
 - 2.2.1. The maintainer exercises all the rights granted to the maintainers of private higher education institutions by the legislation in force.
 - 2.2.2. The maintenance body adopts the university's statutes.
 - 2.2.3. The Board of Trustees shall adopt the budget of the University, the annual accounts prepared in accordance with the accounting provisions, the organisational and operational regulations, the asset management plan, and the Rector's application, subject to the opinion of the Senate.
 - 2.2.4. The Board of Trustees of the Rudolf Kalman Foundation for Obuda University, the maintainer of the University, shall decide on the establishment of a university business entity, the acquisition of shares in a business entity, the termination of a business entity, and the divestment of an interest in a business entity, and the Rector shall inform the Senate of the decision.
 - 2.2.5. It is subject to all the obligations imposed on private higher education institutions by the legislation in force.
 - 2.2.6. It is the responsibility of the maintainer to ensure the material, financial and human conditions for the autonomous operation of the University, within the limits set by law.

3. Purpose and status of the University

- 3.1. The public benefit activity of the University according to its purpose is the pursuit of educational and scientific activities pursuant to Section 2 (1) and (3) of the Nftv.
- 3.2. The University is a state-recognised institution of higher education in Hungary, not a state university, according to Annex 1 of the Nftv.
- 3.3. The University is a private institution of higher education maintained by a foundation registered in Hungary pursuant to Section 4 (1) d) of the Nftv.
- 3.4. The University is subject to the Nftv. 5 (1), is a professionally independent legal entity with self-government.
- 3.5. The University operates as a public benefit organisation in accordance with the provisions of the Nftv. and Act CLXXV of 2011 on the Right of Association, the Public Benefit Status and the Operation and Support of Non-Governmental Organisations and on the basis of the registration of the Education Office.

4. Activities of the University

- 4.1. The core activity of the University (public benefit activity according to the purpose of the Nftv., Section 2 (1)) is education and scientific research.
- 4.2. The core activity of the University:
 - It may provide bachelor's, master's and post-graduate training in the field and at the level of training specified in point 6.3, and award diplomas in such training.
 - It participates in the implementation of public education, vocational education and training and other training tasks defined in the sectoral laws, as provided for in Act CXXXIX of 2005 on Higher Education, the National Education Act, Act LXXVI of 1993 on Vocational Education and Training, Act CXC of 2011 on National Public Education, Act CLXXXVII of 2011 on Vocational Education and Training and Act LXXVII of 2013 on Adult Education.
 - It may pursue higher education vocational training in the field of training specified in point 6.3.
 - undertakes doctoral studies in the field of science specified in point 6.3 and gives a grade.
 - As the founder or maintainer of a public education institution, it carries out public education tasks.
 - It carries out basic, applied and experimental research and development, scientific organisation, technological innovation and other research in the fields of training and scientific disciplines related to education, and exploits its intellectual potential by providing services.
 - It contributes to the preparation of students for an intellectual life by transmitting, cultivating and developing national and universal culture, and by improving their knowledge of their mother tongue and foreign languages.
 - It promotes the dissemination of intellectual assets related to education and research for the benefit of the community.
 - It helps to promote the presentation and exploitation of research activities and results to the corporate sector, and supports the expansion of faculty-level corporate relations at university level.
 - Develop and maintain the international relations necessary to ensure high quality teaching and research.
 - It publishes textbooks and notes and develops teaching tools.
 - It provides textbooks and notes, library and laboratory services, dormitory accommodation, cultural and sporting facilities for students covered by its core activities, and services for the integration, healthy living and health care of students.
 - It carries out tasks relating to the care of workers in its employment in accordance with the relevant legislation.
 - It is responsible for maintaining and continuously improving the University's infrastructure within its own organisation.
 - In order to fulfil its tasks, it operates a functional department for finance and internal audit, as well as administrative, organisational, technical services and other functional departments to ensure its operation.
 - Provides enrolment (skills and communication) activities to support access to higher education.
 - It makes use of the free capacities of the University infrastructure (publishing, printing services, production of printing products, production of industrial products, rental of sports facilities and teaching premises, and dormitory accommodation).
 - It carries out public collection activities and public cultural tasks.

4.4. The University's jurisdiction and area of operation: the territory of Hungary (and outside this territory).

5. Organisation and operation of the University

5.1. Organisational structure

- 5.1.1. The University's organisational structure and the order of its operation, the division of tasks between the managers, and the provisions of further legislation on internal and external relations are laid down in the University's Organisational and Operational Regulations (hereinafter referred to as the "OOA").
- 5.1.2. Faculty and organisational structure of the University:
 - 5.1.2.1. The University shall have faculties and centres as teaching and scientific research units in accordance with Annex 1. The faculties shall organise the provision of training in one or more fields of study or at one or more levels of study which are related to one another in terms of their fields of study as defined in point 6.3. Within the faculties there shall be institutes, departments, external departments and specialised sections.

- 5.1.2.2. The University has a library, which provides library services and information, and a college, which provides educational, social and talent management services.
- 5.1.2.3. In order to carry out its operational tasks, the University maintains economic, administrative, organisational, technical service and other functional departments.
- 5.1.2.4. The organisational structure of the University in accordance with the Nftv., the structure of the individual organisational units and the order of their operation are defined in the SZMSZ.

5.2. Senate:

5.2.1. The main decision-making body of the University is the Senate. The President of the Senate is the Rector. Issues related to the establishment and functioning of the Senate are governed by the Regulations. The Senate determines the University's educational and research tasks and ensures the control of their implementation. The Senate may, at any

time, discuss any issue, take a position on any issue and make a proposal.

5.3. Rector:

- 5.3.1. The University shall be headed by the Rector, who shall be appointed or dismissed by the President of the Republic of Hungary, by public tender, on the basis of a decision of the Senate and the approval of the Reservation, in accordance with the relevant provisions of the Nftv. Rectors may be appointed for a fixed term of up to five years. The Rector's mandate may be extended several times by public tender. The rector shall be subject to the rights of the rector's employer. The Rector's tender shall be issued by the Rector, after obtaining the opinion of the Senate. The Senate formulates its proposal for the Rector's call for applications, evaluates the Rector's applications and elects the Rector-designate, and assesses the Rector's leadership. The detailed rules on the procedure for the application and the appointment of the Rector are laid down in the Rules of Procedure.
- 5.3.2. The Rector shall be the primary, single responsible manager and representative of the University, who shall act and decide on all matters which are not referred to the competence of any other person or body by law, the Statutes or the Terms of Reference.
- 5.3.3. The Rector shall exercise the powers of an employer over the employees of the University in the may delegate this power in the manner specified.
- 5.3.4. The Rector is responsible for the purposeful and effective performance of the University's core activities, the continuous development of teaching and scientific research and artistic creation.
- 5.3.5. The Rector and the Director-General for Finance exercise the powers relating to university-wide commitments.
- 5.4. The Rector and the Senate shall be obliged to observe and enforce the educational, scientific, cultural, innovative and economic goals set by the Rector and the Senate, which serve the interests of Hungary and the University.
- 5.5. Director-General for Economic Affairs (Chief Financial Officer):
 - 5.5.1. The University's economic activities are organised and managed by the Director-General of Economic Affairs, who is a senior member of staff. He manages the assets, is responsible for preparing the budget proposal and monitors the implementation of the budget.
 - 5.5.2. The Director General of Economics is appointed and dismissed by the Reservation, subject to the opinion of the Rector; the Reservation exercises the rights of the employer over him/her, and the Rector exercises the following direct management rights:
 - a) direct supervision of the employee's work performance (including task assignment, supervision, evaluation, ordering work outside of normal duties or extraordinary work, and official travel assignments);
 - b) based on the prior decision of the Rector's Council, the definition of the institutional budget and financial management framework in accordance with educational-strategic principles and foundations;
 - c) granting leave to the employee and controlling the taking of leave, initiating the authorisation of unpaid leave.

- 5.7. The Rector represents the University as its legal representative in dealings with third parties and before courts and other authorities. The Rector may delegate his powers of representation to his deputy or to other senior or managerial staff of the University on a case-by-case basis or for a specific range of matters. In the event of the Rector's inability to act or if he/she is temporarily unavailable, or in the event of a temporary vacancy, the Vice Rector, who is entitled to replace the Rector, as defined in the Regulations, shall act as the head of the University or the Senate, and shall be subject to the rights of the employer, exercised by the maintainer.

7. The public benefit of the University

- 7.1. In carrying out its tasks, the University operates as a public benefit organisation. The University may only engage in entrepreneurial activities without jeopardising its core activities. The detailed rules for entrepreneurial activity are laid down in other management regulations. The University shall not engage in direct political activity and shall be independent of political parties and shall not provide them with financial support.
- 7.2. The University does not distribute its profits, but uses them for its public benefit activities.
- 7.3. Public Benefit Supervisory Committee
 - 7.3.1. The Public Benefit Supervisory Committee is a separate body from the Senate, which supervises the operation and management of the University.


- 7.3.2. The Charity Supervisory Board consists of three members, appointed by the maintainer for a fixed term of 3 years. The members and members may be reappointed for a further term of office.
- 7.3.3. The Performance Review Committee may request reports from the University's executive officers, request information or clarification from employees of the organisation and inspect documents.
- 7.3.4. The Charity Supervisory Committee shall establish its own rules of procedure.
- 7.3.5. The detailed rules on the University's profitability are set out in the Rules of Procedure.

This Articles of Association was adopted by the Board of Trustees of the Maintainer on May 31, 2025, by Resolution No. 54/2025. (V.31.). It shall enter into force on June 1, 2025.

Point 6.5 of this Articles of Association shall be replaced by Point 6.5.1 of this Articles of Association as of August 15, 2025.
